



## Athletic Authorization and Release of Liability

All Athletic Team Practices, Games, Meets and Matches

We/I understand that my child's participation in this sport exposes my child to the risks inherent with that sport which can include serious injury or even death, property damage and impact future physical conditions including the ability to earn income. Knowing these risks, nevertheless, on behalf of said minor child, I hereby agree to assume those risks and to release and hold harmless all persons or entities mentioned below, whom for any reason, might otherwise be liable to me, or my heirs or assigns for damages. I hereby give my permission for the minor(s) I will register to participate in the activities for which I am registering them and hereby waive, release and discharge any and all claims or rights to claims for damages, personal injury, death or property damage which I may have, or which may hereafter accrue to me, as a result of said minor's participation in said activity. This release is intended to discharge in advance, National University Academy, its agents, servants, employees, officers, directors, volunteers coaches, volunteers, team parents and the city in which the activity is taking place from any and all cost and expenses including, but not limited to attorney's fees; reasonable investigative and discovery costs; court costs; liability arising out of or in any way connected with said minor's participation in said activity; and all other sums with National University Academy's assertion of liability or claim of action founded thereon, arising or alleged to have arisen out of our/my child's participation in said activity, or by actions of omission by our/my child.

It/is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. We/I also understand that if we/I do not agree with this release of liability, we/I may not enroll any children in the National University Academy sports program. We/I agree to pay for any equipment or uniforms issued to out/my player that is not returned at the end of the season on turn in day.

INFORMATION: Education code section 35330 authorizes the governing board of any school district to conduct field trips or excursions for students in connection with the course of instruction or school related social, educational, cultural, athletic or school band activities to and from places in the states, the District of Columbia, or a foreign country. Field Trips or excursions may be connected with such courses of instruction or such school activities that further the student's education and participation is voluntary.
